New Business: Special Use Permit (Orig # 37-1) Modification Application # 14-1\* of Howard & Rebecca Leach to add a hot dog cart to their produce stand in an Ag District on their property 2669 Rte. 14.

Motion by JM 2<sup>nd</sup> Marty to accept the application as complete, carried.

Mr. & Mrs. Leach request to add a hot dog cart to their existing produce stand Special Use Permit which is a modification of use per Torrey Zoning Code in Ag District and was filed with the Town of Torrey Zoning Board of Appeals (hereinafter ZBA) and,

WHEREAS, after due public notice of such, a public hearing on said application was held by the ZBA on July 7, 2014 in the Town meeting room at 56 Geneva St Dresden, Yates County New York, at this time information was presented on the applicants behalf, and

WHEREAS, at said hearing all desiring to speak in favor or opposition of this application were allowed to speak, now,

**THEREFORE BE IT RESOLVED** that the application SUP Modification # 14-1\* (# 37-1 original) for Howard & Rebecca Leach of 2669 Rte. 14, to add a Hot Dog Cart selling hot dogs, hamburgers and drinks to their produce stand. Cart in operation summer months only, Saturday & Sundays 11AM to 6PM is hereby GRANTED.
