Application Area Variance # 15-9 1720 Rte 14 Christopher Missick has rented the side of barn for the advertising of Bellangelo Winery, a business more than 10 miles away from sign location. This sign exceeds the size limit for offsite signage as regulated in the Town Zoning Law.
