

Town Board Minutes
May 11, 2010

The regular May meeting of the Torrey Town Board held at 56 Geneva St. Dresden, was called to order at 7:30 PM by Supervisor Flynn.

Mr. Flynn led the pledge of allegiance

Mr. Flynn presented the abstracts of vouchers for audit.

Motion by Mr. Morris 2nd Mr. Martini, that the bills on the General A & B Funds in the amount of \$ 3,968.98 be paid, carried by all.

Motion by Mr. Martini 2nd Mr. Morris, that the bills on the Highway DA & DB Funds in the amount of \$ 4 36,520.67 be paid carried by all.

Motion by Mr. Martini, 2nd Mr. Morris that the 2nd installment on the 2010 Fire contract in the amount of \$ 42,000. be paid carried by all.

Motion by Mr. Morris, 2nd Mr. Martini that the bills on the SD Watershed Fund in the amount of \$ 694.71 be paid, carried by all.

Motion by Mr. Martini, 2nd Mr. Morris authorizing the Supervisor to sign an Indemnification Agreement with Yates County Highway Dept., carried by all.

Motion by Mr. Martini, 2nd Mr. Morris appointing Linda Lefko to the Board of Assessment review for a term to May 2015, carried by all.

Motion by Mr. Morris 2nd Mr. Martini, to re-appoint Anthony Cannizzaro to the ZBA term to May 2015 and Jon " Jack" Hessney to the Planning Board for a term to May 2015 carried by all.

Highway report given. Mr. Mashewske reported that the old roller brought \$ 4000. at the auction, this will be split with Milo. Co owner of old and new roller.

A tree was cut down at the Town's public beach property, upon further investigation it was determined that neighboring property owner contracted this tree service and has two boats and construction debris lying on the right of way. Clerk instructed to send letter to owner to clear right of way and no further contracted work on Town property without Towns written permission.

A discussion regarding rental properties and neighboring properties that use the parking lot at the park. Signs will be installed that when park is closed, all vehicles will be towed at owners expense.

Code / Watershed written report submitted as Mr. Kenville was absent.

Motion by Mr. Morris, 2nd Mr. Martini to approve the minutes of the April 13th meeting as written carried by all.

Tim Dennis reported for YC Legislator, the County will not be spending extra \$\$ on highways due to no state funding, presently funding for present running state programs is not coming in right now due to the budget not passing. The county is not anticipating CHIPS funding this year so projects are delayed and some halted indefinitely.
