From the Desk of Town Supervisor (*Pat Flynn*):

- The Town has been awarded \$130,000 under the American Rescue Plan. A portion of this will be shared with the Village of Dresden
- Jeremy DeLyser of the engineering firm CPL sent for the February 9th board meeting a punch list of the next steps outlined for WD1.
- Easements necessary for WD1 have been reviewed by the Town Attorney and sent to the affected homeowners. There remains just one (1) final easement to be obtained
- Negotiations with Norfolk Southern for easements under their tracks are ongoing with just one more to be secured

From the Desk of the Town Board:

- The Town Board meets the second Tuesday of the month at 7:30pm
- The Town has been awarded \$9300 from Yates County under its Natural Resource and Recreation Program
- The Town Logo contest concluded April 9th. The entries were reviewed by the Logo Committee led by Town Historian Nancy Sarver. Winners were announced at the May 11th meeting.

HEARING OF COMPLAINTS

APPOINTMENTS ARE REQUIRED FOR GRIEVANCE, and MUST BE MADE PRIOR TO 4PM ON MAY 20TH. Hearings will be held by phone only. Call the Assessor's office to schedule M,W,TH 10am-2pm. Complaints may also be reviewed by mail as long as the documents are received by May 27th. Documents received May 28th are not timely filed and will not be heard. The Board of Assessment Review will meet on Thursday, May 27, 2021 at the Benton Town Hall, 1000 SR 14A, Penn Yan NY between the hours of 4:00pm and 8pm p.m. to hear and examine all **scheduled phone** complaints in relation to assessment on the application of any person believing himself to be aggrieved. **The BAR will call the complainant at their appointed time.**

If you need one mailed, call the Assessor's office. **Attendance with your complaint is not necessary to have it heard; only the timely filing of the completed complaint form.**

From the Desk of Town Clerk (*Betty Daggett*):

- Town Office is open Monday through Thursday from 9:00 am - 4:00 pm. On Friday, the Town Office is open 9:00 am - 12:00 pm. The office phone number is 315.536.6376
- Fee collection such as building permits, fines & fees issued by Code Office
- Licenses : marriage, hunting, fishing, dog & birth/death certificates (If you love your dog(s), please license them. Licensing helps with Identification of lost dogs and provides protection for the community. It is also NYS Ag & Market law- **ALL** dogs harbored in the Town of Torrey must be licensed yearly at the Town Clerk office).
- The Summer Recreation program is to be determined based on the lifting of COVID-19 restrictions

From the Desk of Town Highway Superintendent (*Tim Chambers*):

- Off hours emergency callout number: 315-729-2706
- A growing problem in the Town of Torrey is the **stealing** of our street signs e.g. Hopeton Road, Jensen Road, Nutt Road, and Quenan Road. The stealing of street signs is a punishable crime subject to a \$100 fine and/or one year confinement. The Town of Torrey is offering a \$100 reward leading to the information and identification of the culprit(s).
- The Town Salt Shed constructed in 2014 should be power washed and sealed every five (5) years. Hybrid Building Solutions has submitted a proposal to perform the work for \$6011.
- Consolidated Local and Highway Improvement Projects (CHIPs) funds (approximately \$65,000 in previous years) are expected to be

fully funded at \$145,000. A portion of this money will be used to pave Hewitt Rd as well as seal Hopeton Rd which was paved last year.

- Yates County reimbursement for shared services is \$26,000. The Town was expecting \$44,000. This is dependent on snow plowing in the months of November and December.
- NYS DOT has reinstated the 20% cut in funding for 2020.
- Tim will sign for the Town of Torrey a shared services agreement with NYS DOT.
- Snow removal season has ended so the highway department has now turned to Spring tasks- patching potholes, mowing roadsides, sweeping roads, drainage work, etc.
- Investigating replacing the Town's 2017 ¾ ton pickup from the department's equipment fund as its resale value is quite high
- Torrey Cleanup Days is tentatively scheduled to be held August 15th from 8:00 am to 2:00 pm (see more details under **Upcoming Community Events**)
- *Reminder according to NYS law:*
 - + throwing trash, garbage, rubbish, litter or refuse on Highways and adjacent lands is prohibited
 - + the town superintendent of highways shall sue for and recover a penalty not to exceed \$100 from any person depositing ashes, snow, ice, stones, sticks, etc. upon a hwy or on grass or loose stones adjoining a town hwy

From the Desk of Town Code Enforcement Officer (Dwight James):

- Call the Town Office at 315-536-6376 (cell 315-730-3291) or email at torreycodes@gmail.com to inquire about Permits. When in doubt ask!
- The new New York State Building Code took effect on May 12, 2020. Check with Dwight for additional information
- Building permits are required for any electrical, plumbing, insulation, or structural work undertaken
- Construction or alteration of any accessory structure, addition or

- new construction requires a permit
- Reminder all short term rentals must be registered with the Town
- There has been a noticeable increase for inquiries and/or permits for commercial projects. There were 2 special use permits scheduled for April and at least 1 more in May.
- The total permits issued to date are 52.
- Dwight has completed ½ of his required 24 hours of code classes.

From the Desk of Town Planning Board (*Dave Granzin*):

- Meets the third (3rd) Monday of the month at 7:00 pm in the Town Building. Because of COVID-19 restrictions meetings will temporarily held in the Town garage.
- Revised the town's Dog Kennel Law and submitted to the Town Board for adoption. The Town Board will review at the May 11th meeting at 7:30 pm.
- The review of Greenidge's proposed data farm continues. In November the Planning Board issued a conditional negative SEQR declaration. A subsequent Article 78 procedure resulted in the Yates County Planning Board issuing a negative recommendation on Greenidge's permit. This moved the permit process back to the Torrey Planning Board for a second review. A full SEQR review was held at the April 19th meeting. The Planning Board voted 4 - 1 to pass a negative SEQR (meaning no environmental finding). By the same margin the site plan was permitted on the condition a noise study be performed and the results meet the Town Building Code.
- A review of Norbut's solar farm permit was held at the April 26th meeting. The Planning Board voted 4 - 1 to pass a negative SEQR and by the same margin approved the site plan.
- Moved two (2) items to the Zoning Board of Appeals for special use permit. One is the building of a 72 ft x 140 ft warehouse to manufacture storage sheds. The other is a three (3) phase expansion

of the Red Tail Winery conditional on County Planning Board approval.

From the Desk of Town Watershed Inspector (*Yates Cty Soil & Water*)

The Town's inspectors can be contacted at the Yates County Soil and Water Conservation Department 315- 536-5188.

Yates County Soil and Water led by Colby Petersen is working with the Town of Torrey Highway Department in the remediation at the Town Park through a Yates County Natural Resource and Recreation Grant.

Yates County Soil and Water led by Colby Petersen is working with Ian Smith, Seneca Lake Watershed Steward, in the implementation of a Yates County Natural Resource and Recreation Grant for flood control of sediment and nutrients in sections of the Keuka Outlet.

In November of 2014, the Town of Torrey passed a local Wastewater Law effective January 1, 2015. Under the new law, any onsite wastewater treatment system within 200' of Seneca Lake or a DEC classified stream is required to be inspected every 5 years. The cost of the inspection is borne by the Town of Torrey (unless this is a property transfer). However any pumping of the septic or repair is a cost to the homeowner. We are now in year 7 of these inspections.

- Village elections were held Tuesday, March 16,2021
- Village organizational meeting will be held Wednesday, May 19th at 7:00 pm which is the regular monthly meeting
- The public hearing for the Village Budget was held on April 21st The tax rate is below the New York State Tax Cap.
- The date for the “Dresden Days” celebration is Friday July 23rd and Saturday July 24th. (Dresden Days will be held the third Friday & Saturday of July every year).
- The Village hopes to have Live Music at the Gazebo the First Tuesday of the month – May, June, July and Aug
- Dresden Fire Department meets the first Monday of the month
- There is a need for volunteer firemen in Dresden. All residents of the Town of Torrey are encouraged to volunteer.
- Greenidge Power Plant donated \$25,000 to the Dresden Fire Department for rescue equipment. The volunteers of the fire department contributed another \$9,000 from their fundraising efforts to purchase complementary equipment.

- **Seneca Lake Pure Waters Association (SLPWA)** stream sampling in the Keuka Outlet began April 5th. Sampling is not as robust as in previous years as it is now done in conjunction with the Department of Environmental Conservation (DEC). Harmful Algal Blooms (HABs) monitoring will start in early August and will continue through the beginning of October. Check the website www.SenecaLake.org for additional information or to volunteer!
- **Memorial Day Observance** for the Town of Torrey is to be held at the Gazebo in Dresden (across from the United Methodist Church) at 10:30 am on May 31st. The main speaker will be Reverend John Busch. COVID-19 protocols should be followed! Following the ceremony at the church, there will be a parade to the Evergreen Cemetery. At the cemetery the Roll Call will read of the deceased veterans and saluted by the American Legion, which will be followed by Taps courtesy of Phil Bracht and Jeff Stempien.
